The Zanzibar Maisha Bora Foundation (ZMBF) invites eligible national individual consultants or consulting firms to submit Technical and Financial Proposals for the development of its Second Strategic Plan (2025/26–2029/30). This tender is issued in reference to the **Terms of Reference (TOR)- (ANNEX A)** for the assignment, which outlines detailed objectives, scope, methodology, deliverables, and expected outputs.

# A. Objective of the Assignment:

To facilitate the design of a results-based Strategic Plan that defines ZMBF's priorities, outcomes, and interventions; establishes a monitoring and evaluation framework; and provides a resource mobilization and sustainability strategy aligned with national, regional, and global development priorities.

### B. Scope of Work (Summary):

- i. Desk review and situational analysis of ZMBF's first Strategic Plan and related evaluations.
- ii. Inclusive stakeholder consultations with ZMBF Board, staff, beneficiaries, government, UN agencies, CSOs, private sector, and donors.
- iii. Development of a strategic framework with results-based M&E, risk management, and resource mobilization strategies.
- iv. Validation of draft plan and preparation of the final Strategic Plan (2025/26–2029/30) and Year One Implementation Plan.

## C. Eligibility / Minimum Qualifications:

### For Individual Consultants:

- i. Master's degree in development studies, Economics, Public Policy, Social Sciences, or related field.
- ii. Minimum 7 years' proven experience in strategic planning, results-based management, and organizational development.

- iii. Experience leading strategic planning for NGOs/foundations in Zanzibar/Tanzania.
- iv. Strong facilitation, analytical, and report-writing skills.
- v. Fluency in English and Kiswahili.

# For Consulting Firms:

- Proven track record of providing strategic planning and organizational development services.
- ii. Minimum of 7 years' experience in leading strategic planning assignments, preferably with NGOs or foundations.
- iii. Demonstrated experience working in Zanzibar/Tanzania or East Africa.
- iv. Strong team of experts with relevant qualifications in development, policy, or related fields.
- v. Fluency in English and Kiswahili among team members responsible for the assignment.

Interested **individuals** or **firms** must submit the following documents:

- i. Cover Letter / Expression of Interest indicating suitability, availability, and whether submission is as an individual or firm.
- ii. Technical Proposal (understanding of the assignment, methodology, work plan, relevant experience).
- iii. Financial Proposal (detailed cost breakdown including professional fees).
- iv. Updated CV (for individuals) or Company Profile (for firms).
- v. Academic and Professional Certificates.
- vi. Legal & Compliance Documents:
  - i. For individuals: TIN certificate and tax clearance.
  - ii. For firms: Valid business license, TIN certificate, VRN certificate, and tax clearance.
- vii. References / Evidence of Past Work (at least two previous similar assignments or reference letters).
